

Caravan Sites and Control of Development Act 1960

APPLICATION FOR A SITE LICENCE

To: **London Borough of Bromley**

I hereby apply for a licence to use the land described below and shown on the attached plan (See Note below) as a site for caravans to be used and laid out as specified below:

Foul and surface water drainage	Toilet blocks	Notices
Electric Supply	Electric hookups	Overhead electric pylons
Site Lighting	Gas Supply	Gas Storage

The plan should distinguish between facilities already provided and facilities proposed.
