**TOWN AND COUNTRY PLANNING
(GENERAL PERMITTED DEVELOPMENT) ORDER 1995**

DIRECTION MADE UNDER ARTICLE 4(1)

BIGGIN HILL AIRPORT

WHEREAS the Council of the London Borough of Bromley, being the appropriate local planning authority within the meaning of Article 4(6) of the Town and Country Planning (General Permitted Development) Order 1995 are satisfied that it is expedient that the development of the descriptions set out in the Schedule below should not be carried out on the land shown edged red on the attached plan, unless permission is granted on an application made under Part III of the Town and Country Planning Act 1990

NOW THEREFORE the said Council in pursuance of the power conferred upon them by Article 4(1) of the Town and Country Planning (General Permitted Development Order) 1995 hereby direct that the permission granted by Article 3 of the said Order shall not apply to development on the said land of the descriptions set out on the Schedule below

THE SCHEDULE

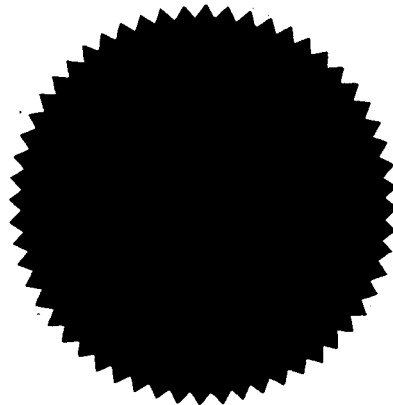
The carrying out on operational land by a relevant airport operator or its agent of development (including the erection or alteration of an operational building) in connection with the provision of services and facilities at a relevant airport within the scope of Class A of Part 18 of Schedule 2 to the 1995 Order PROVIDED THAT nothing herein shall prevent development which falls within the scope of paragraph A.4 of Class A of Part 18 of Schedule 2 to the 1995 Order.

NOTE: References in this Direction to the 1995 Order mean the Town and Country Planning (General Permitted Development) Order 1995/418.

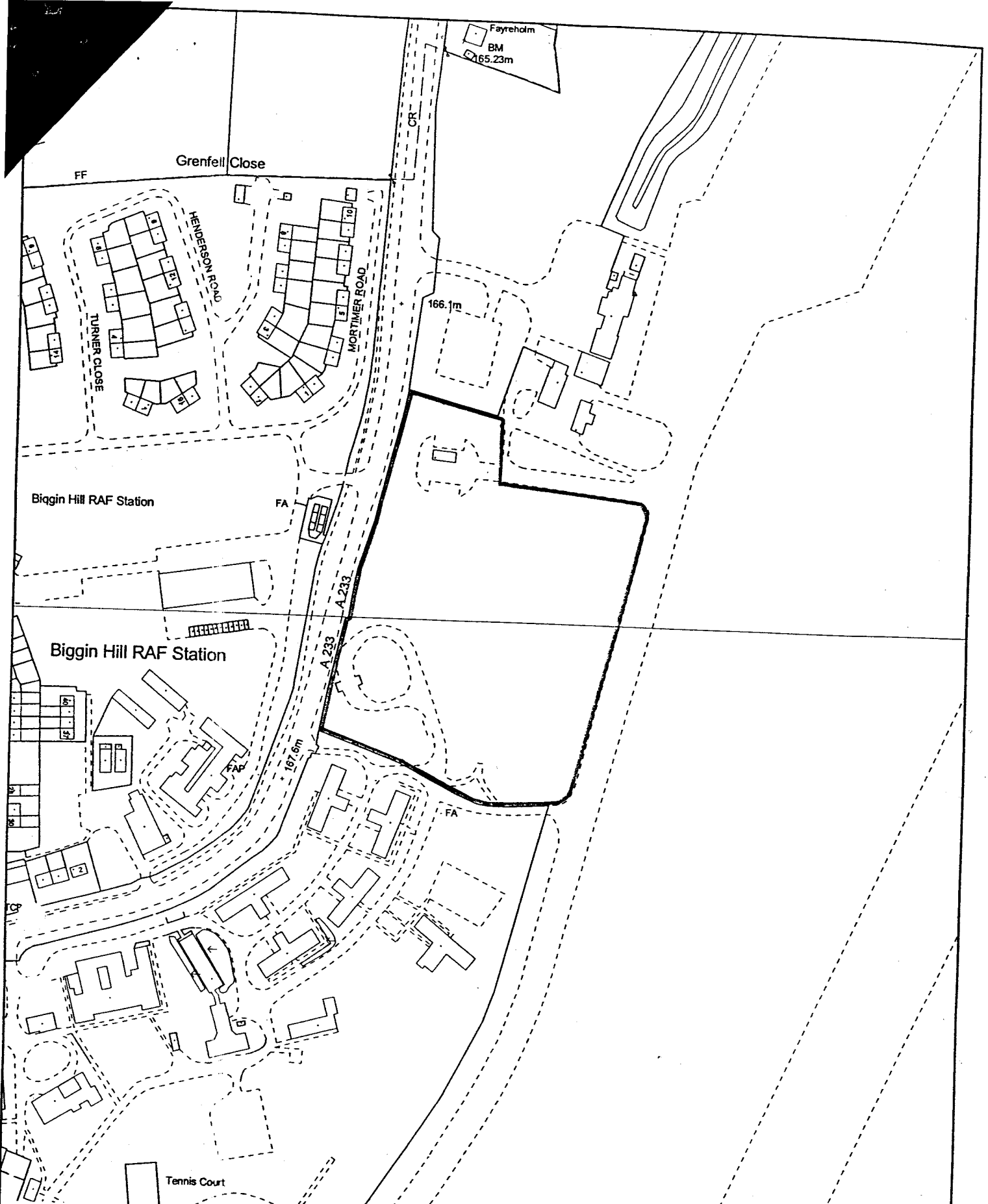
