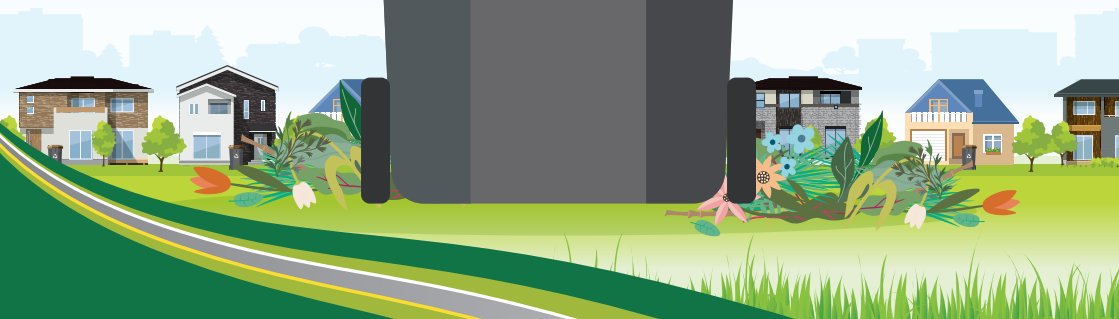
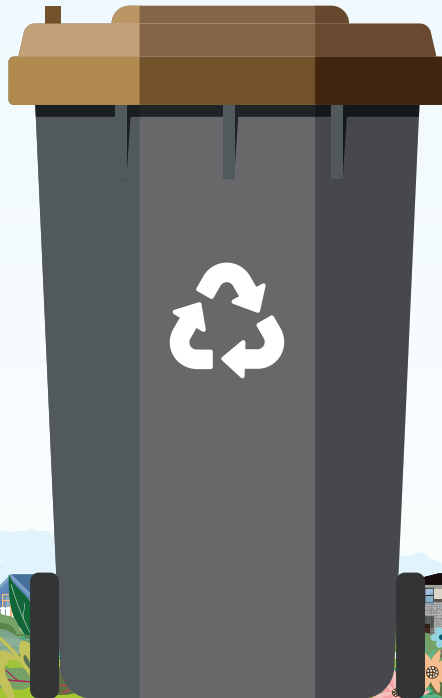

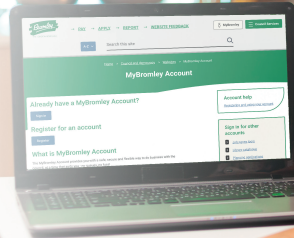
MyBromley Account

You can now apply for Housing Benefit and Council Tax Support online and can view your account on a computer, laptop or mobile device.

You can access your MyBromley Account at any time, night or day. Tell us about a change in circumstances when it suits you, without the need to telephone, write in or visit the Council office.

DIRECT PAYMENTS

YOUR CARE - YOUR WAY

A direct payment is money that is paid to you by the Council or the NHS so you can pay for your own care and support.

Direct payments,
your care, your way.

WHO CAN RECEIVE DIRECT PAYMENTS?

- Adults who receive care support from adult social care services
- Parents of disabled children receiving support from children's social care

For those receiving health services, they may be eligible for a personal health budget direct payment if they are:

- An adult who is eligible for NHS Continuing Healthcare
- Parents of children in receipt of continuing care funding
- An adult who is eligible for Mental Health Act, Section 117, after-care services
- Eligible for a local wheelchair service

DIRECT PAYMENTS CAN BE USED FOR



Personal care and assistance to help you live in your own home - which can be carers sourced through an agency or a personal assistant that you choose and employ directly



Support to access things outside of the home - such as the community, social and leisure activities, and transport

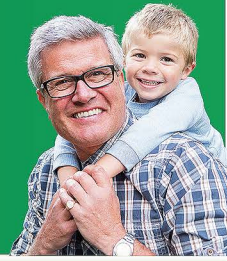

You could be the foster carer they need.**

Could you help our children?

Roman is 14, he lives alone with his mother who has been hospitalised for mental illness. He requires a short term foster placement until a family member can care for him.



Could you help our children?

Alex (2), Bobby (6) and Max (9) are siblings, their parents are regular drug users and the children often witness domestic violence. The courts have determined that they could thrive better with the care of a long-term placement.



Could you help our children?

Beatrice is 15 and 7 months pregnant, she does not have any family that can support her and requires a parent and child placement so that she can get the care and support she needs to look after herself and her new baby.

Be ready for Voter ID this year

You now need photo ID to vote at a polling station including in the Mayor of London and Assembly elections on Thursday 2 May and the next general election

Check now that you have valid identification. There are lots of forms you can use for elections, the most common are listed on the back and the full list available at www.bromley.gov.uk/VoterID

Do you have photo ID for the next election?

There's lots of forms you can use on the 2 May London elections and for the next general election, including:

- Passport (UK, EEA or Commonwealth)
- Photocard Driving Licence – full or provisional (UK, Channel Islands or EEA)
- Biometric Residents Permit
- EEA Photographic National Identity Card
- Oyster 60+ Card
- Freedom Pass
- Disabled Person's Bus Pass
- Blue Badge
- PASS Card (Proof of Age Standards Scheme)
- MOD Form 90 (Defence Identity Card)



If you do not have any accepted form of identification, apply for an alternative now to ensure that you can vote
